Background

The INTOSAI-Donor Cooperation (Cooperation) has taken the initiative to develop fact sheets for the purpose of increasing knowledge of member practices in supporting Supreme Audit Institutions (SAIs). Fact sheets have been developed for donor members who can provide financial support for capacity development. In addition, fact sheets have been developed for some INTOSAI members who can support capacity development for SAIs through their programme implementation.

About GAC

Global Affairs Canada is the government department responsible for leading Canada's international development and humanitarian assistance. GAC provides bilateral support to partner countries and other types of support to a number of focus countries.

GAC can support SAIs through multiple types of projects, see table 1 for an overview. These type of projects covers duration and delivery approaches, and are not mutually exclusive.

Programme Cycle and decision making

GAC do not have a set programme cycle. Decision on country level support to SAIs are usually taken jointly by the country office and staff at the Headquarter. The decision to support a given sector is based on the thematic priorities of the department. The Country or Regional Strategy, approved by the

Minister, sets the five-year high-level strategic direction for a country program. Country Programs report on strategy and review programming annually to determine whether changes in the country context or Canadian foreign and/or development policies call for changes in strategic direction.

Strategic priorities for GAC

Priority countries

The Canadian Government has 25 countries of focus. In addition, Canada also maintains significant bilateral aid programs with numerous partner countries. To consider supporting a SAI, the SAI has to be from one of GAC's countries of focus or partner countries. For an overview of the countries of focus/priority countries see table 2 below:
