Welcome to the BUSS workshop for the OLACEFS¹ region, Panama City, 22nd-25th August 2023

1. **Background:** The <u>INTOSAI-Donor Cooperation</u> launched a new initiative to continue capitalizing from the collaborative global platform in place, maximize joint efforts and increase support to Supreme Audit Institutions (SAIs) in need. The objective of the <u>BUSS initiative</u> is to link available sources of support with SAI

- development plans by first proactively identifying resources, second, assisting SAIs in articulating their needs and third, enabling opportunities for engagement for both SAIs and partners. The INTOSAI Development Initiative (GFU Unit) facilitates the execution of the initiative by
 - (i) Identifying resources globally before inviting SAIs to apply
 - (ii) Delivering regional workshops to enhance SAI competence in building strategic partnerships and developing proposals
 - (iii) Holding regional working sessions with partners to increase their knowledge about SAIs and their role within the PFM system, understand their priorities, map support in the region and encourage partnerships and coordination
- 2. **Objective**: To foster strategic partnerships amongst partners and SAIs, strengthen coordination and advocacy of the SAI role as part of the strengthening of Public Financial Management systems in the OLACEFS countries.
- 3. **Scope:** Whether you are new to the work of Supreme Audit Institutions or are already engaging with them, this will help you to:
 - ✓ Understand how SAIs work and their role within PFM system
 - ✓ Find synergies, network and ways of collaboration within the region to allow achievement of common goals and maximize SAI support
 - ✓ Understand and advocate for SAI Independence and the power of institutional coordination
- **4. Target audience**: Development partners, donor bodies or organizations at either a regional or country-level, working within the Public Financial Management and Governance Sectors and on strengthening accountability systems and citizen engagement within the OLACEFS Region.
- 5. **Structure**: The BUSS workshops for partners (22nd to 24th August) and SAIs (23rd to 25th August) are linked and delivered sequentially. The program for the donors and development partners includes closed sessions for partners on the 22nd of August and joint working sessions and roundtable discussions with SAIs on the 23rd and 24th of August. The 25th of August closed sessions for the SAIs will be delivered; although partners can stay and hold bilateral meetings if useful.
